FOREWORD

The 2021 local government ordinary elections continued the Commission's success in attracting local government clients. A record 98 local governments conducted their ordinary elections using the Commission's services in 2021. Overall, the elections ran very smoothly, and our returning officers reported few significant problems.

Many local governments choose the Commission to conduct their ordinary and extraordinary elections because of our reputation for impartiality and integrity. This is greatly valued in a world where trust in government at all levels is reported to be declining. The Commission is confident that its processes are robust and accountable but as always, we strive to improve our services based on feedback from our staff, local governments, community members and candidates.

The Commission's work commences many months prior to polling day with election budget estimations, briefings for local governments and continues with candidate information sessions and advice to candidates and electors right up until polling closes. We also then complete the important work of counting the votes and declaring the result.

All of this work is completed conscientiously and diligently by our head office and temporary staff. I would like to thank everyone involved in this year's elections, particularly those who also contributed to the state general election earlier in the year. The Commission's success is reliant on the very hard work of all of our staff, and they should be proud of the contribution they make.

Elector participation increased from the 2019 result to 30.2% in 2021 although it remains stubbornly between the range of 25 and 35% over the last ten years. 941 candidates nominated which was lower than the 2019 figure. 79 candidates were elected unopposed with 177 out of the 217 ward, district, or mayoral elections for 98 councils conducted by the Commission going through to a contested ballot. Eight vacancies across six councils were unfilled due to insufficient nominations. Four out of 13 mayoral contests were completed with no election necessary due to only one candidate nominating.

The intensity of candidate behaviour in some elections and the resulting engagement with the Commission was considerably higher than others and also higher than for the state general election. While it is pleasing to see such enthusiasm for democracy at the local level of government it does create considerable work for our returning officers and complaints team in responding to many allegations of apparent inappropriate behaviour. The Commission considers all serious allegations carefully but will work to improve candidate and wider community awareness for future elections concerning interpretation and application of the legislative framework governing these elections. Hopefully this will reduce many of the queries raised with our staff and help everyone enjoy a more successful election process.

The Government has announced proposed changes to the *Local Government Act 1995* (the *Act*) which, if adopted in time will require the Commission to adapt its operating model for the next ordinary elections in October 2023. Planning for this work will commence once the final amendments are clear.

In concluding, I would like to again acknowledge the efforts of all returning officers and Commission staff and thank each of the local governments for the assistance and cooperation provided by their staff.

INTRODUCTION

This report provides a brief description of the processes involved in conducting the 2021 local government ordinary elections and includes a summary of the results.

The *Local Government Act 1995* allows councils to conduct their own elections as in person ballots, but only the Electoral Commissioner may conduct a postal voting election.


The Commission's involvement in postal elections has increased at successive local government elections, conducting a record number of 92 postal elections in 2021. We also assisted with six in person elections.

Local governments participating in postal elections in 2021 are listed at Appendix 1.

All local governments located in the metropolitan area and major regional locations adopted postal voting.

Six local governments requested the Electoral Commissioner to conduct in person elections. These local governments were the Shires of Broome, Cocos (Keeling) Islands, Derby-West Kimberley, Halls Creek, Menzies, and Tammin.

A timetable for the 2021 elections can been seen at Appendices 2 and 3.



Key Events

Conducting large numbers of simultaneous postal elections demands a high degree of planning and scheduling to meet the requirements of the election process. Some of the key election activities for the Commission include:

- providing cost estimates to each local government
- conducting client liaison meetings
- close of the electoral rolls
- opening and close of nominations
- printing and dispatch of postal voting election packages
- receipt and checking of postal voting election packages
- conducting numerous counts and declaring results.

RETURNING OFFICERS (RO's) AND STAFF

Returning officers (RO's) are the primary contact for candidates, councils, media, and the public so where possible the Commission endeavours to secure someone local with the necessary skills for this role. They participate in training sessions delivered by the Commission and are also assigned a Returning Officer Liaison Officer (ROLO), an experienced former RO for guidance and support throughout the election.

With 98 local governments spread from Esperance in the south up to Wyndham-East Kimberley in the north of the State, and remote locations involving Halls Creek, Derby-West Kimberley, Menzies and Wiluna, diverse and complex challenges of delivering election services for these local governments can vary greatly between different locations.

The Commission employed 98 ROs and four ROLOs for this election, they were supported by casual staff who assisted with vote counts in each local area and at the processing centre.

Local governments made their staff available for the issue of replacement and provisional voting papers during the lead up to election day. In addition, one or more staff from most local governments worked at the polling places on election day and/or were employed to count ballot papers after 6.00 pm.

The names of all Commission employed Returning Officers are listed at Appendix 4.

ADVERTISING

The *Act* requires the placement of three statutory advertisements. Changes to regulations in August 2020 now provide that statewide public notice can be achieved by publication on the official website of the local government and the website of the Western Australian Electoral Commission, exhibition on a local government noticeboard or by electronic means, including social media.

The following notices were published in accordance with the above requirements:

- Notice of Close of Enrolments
- Call for Nominations
- Notice of Election.

Notices advising of the election results were published in a similar manner to the other notices.

People visiting the Commission's website site could access a broad range of electoral information, including:

- key dates and deadlines for the election
- how-to-vote information
- previous postal voting election results
- lists of candidates (after close of nominations)
- profiles and photographs of the candidates as supplied by the candidates
- RO contact details
- Australia Post daily package return figures
- final election results.

ELECTORAL ROLLS

The electoral rolls closed at 5.00 pm on Friday 27 August 2021.

The Commission produced residents rolls for 137 Western Australian local governments with elections. There were a combined 1,740,355 electors on the residents rolls statewide.

Each local government Chief Executive Officer was responsible for producing an owners and occupiers roll for their district.

Candidates were able to obtain copies of the rolls for the areas they were contesting once they had nominated.

NOMINATIONS

Nominations opened on Thursday 2 September 2021 and closed at 4.00 pm Thursday 9 September 2021. To nominate as a candidate for a local government election, candidates must make a valid nomination application which must be presented to the Returning Officer before 4.00 pm on the day of close of nominations. A valid nomination consists of a complete nomination form, a candidate profile, a deposit of \$80 and a photograph (optional).

For 2021 an amendment was made to the *Local Government Regulations 1996* where the candidate profile was to contain no more than 800 characters including spaces. This was a welcome change and ensured consistency in size amongst the candidate profiles. Previously the profile was a maximum of 150 words which resulted in the overuse of hyphenated words that distorted the accuracy of an electronic word count.

A total of 905 candidates nominated across the 92 postal elections and 36 for the six voting in person elections conducted by the Commission. The City of Gosnells and the City of Stirling had the most candidate nominations, each receiving a total of 28.

Nomination builder

The Commission has developed an online software application called *Nomination Builder* to assist candidates to prepare their nomination. The application allows candidates to enter their details, input their candidate profile and upload an optional photograph. Once completed, candidates could print their nomination form, sign it and lodge with the RO. Nomination Builder continues to be the preferred method of preparing nominations with 91.6% of candidates having used nomination builder prior to meeting with the RO.

Gender of Candidates

Over the last few elections, the Commission has witnessed an increase in gender equality amongst candidates and those elected. In 2021 there were 372 female candidates, making up 39% of the total candidates. There were 568 males (60%) and one unspecified candidate who nominated for vacancies. In 2019 there were, 366 females (35%), 662 males (64%) and one unspecified candidate that nominated for vacancies.

Of those elected, 198 were female (42%) and 265 were male (58%), compared to 184 females (41%) and 259 males (59%) in 2019.

Age of Candidates

The ages of candidates ranged from 18 to 83 years, with an average of 52. This is slightly lower than the average age of 54 in 2019.

Uncontested and Unopposed Elections

Of a total of 217 possible elections, 177 were contested while 40 were uncontested. For uncontested elections, candidates are elected unopposed as the number of nominations received is equal to or less than the number of vacancies. For postal elections, 77 candidates were elected unopposed and two candidates were elected unopposed for the in person elections.

NB: the above figures relate to both election types (postal and in person) which differs from the 2019 report.

COMPLAINTS

Over the 2021 local government period the Feedback team at the Commission's Head Office received over 400 queries and complaints. Complaints were made and resolved through a variety of channels, typically commencing with the RO. As a consequence, many straight-forward complaints were addressed without the need to refer the matter to the Feedback team.

Typical issues involved misleading material, authorisation, social media activity, signage and candidate and campaign conduct. Matters were dealt with in accordance with the Act and associated regulations. Most issues were able to be resolved within two working days, with a small number of more complex matters requiring more time.

Invalidity complaints

Under the *Local Government Act 1995*, invalidity complaints may be made in relation to an election. These complaints are lodged with the Court of Disputed Returns.

STAKEHOLDER FEEDBACK SURVEYS

Surveys were conducted by the Commission seeking feedback on particular aspects of the local government elections from local government Chief Executive Officers, ROs and candidates.

A summary of the key findings from these surveys can be found in Appendix 5.

PROCESSING ELECTION PACKAGES

Election Package Dispatch

There were 1,635,288 election packages dispatched to electors in 79 local government districts (including three wards where there was a mayoral election only).

Electors typically had around two and a half weeks to return their ballot material or over three weeks in many country and remote locations. Electors who misplaced their ballot material could arrange for cancellation and re-issue through their local council.

Statistics on the number of replacement and provisional votes issued in each local government are provided at Appendix 6.

Over 52% of replacement voting papers were issued on election day, probably because electors expected to be able to attend a polling place as they do in the State or Federal elections.

For in person elections, an elector wishing to cast an absent vote could do so at any local government office throughout the State.


Postal Vote Operation Centre

The Commission's centre for postal vote operations was located at the processing centre 30 Beaufort Street, Perth. Casual staff members were employed in teams to process ballot paper envelopes returned by voters.

Mail was delivered to the processing centre by Australia Post on a daily basis from 28 September 2021.

Approximately 28.8% of the total number of packages that were returned were received at the processing centre by the end of the first five business days. This compares with 38.9% of packages returned in 2019. The timing of school holidays and the Queen's Birthday public holiday clearly has an impact on return rates at postal elections.


The following graph illustrates the trend for the return of packages.

Where an election package was rejected (for example, unsigned) the reason was recorded. Appendix 7 shows the number of rejected packages by local government and the reasons for rejection.

Counting of the Votes

Under the first-past-the-post voting system, voters are required to tick up to the number of vacancies specified on the ballot paper.

In local governments with one or two vacancies on the ballot paper the count was conducted manually.

Where the number of vacancies was greater than two in any one ward or where there was a large number of candidates, the Commission determined that a computer count was more efficient. This type of count has a high degree of accuracy for the more complex counts and is typically faster.

As counting in each election was completed, the results were posted to the Commission's website.

In accordance with regulation 81, a report of the results of the elections was sent to the Minister for Local Government on 28 October 2021. Each local government also received a detailed statistical report specific to their election.


RESULTS

The results for all mayoral and councillor elections are shown in Appendices 8 and 9 respectively.

Sitting Members

Out of a total of 471 vacancies, 463 were filled, with 232 (49%) sitting members were re-elected and 239 (51%) non-sitting members were elected.

As observed in the 2019 Local Government Elections Report, even allowing for former councillors returning to service after a period of absence, this constitutes a high level of renewal.

PARTICIPATION

In the 2021 ordinary elections the following local governments were new to the postal voting method:

- Shire of Bruce Rock
- Shire of Dundas
- Shire of Yalgoo

Appendix 11 compares enrolment and voter participation for local governments using the postal voting method in 2017, 2019 and 2021.

The overall participation rate 30.2% increased by 1.1%, compared to 29.1% in 2019. Eleven local governments had an increase in participation rate of more than 5% and six local government's participation rate decreased by more than 5% in 2021 compared to 2019.

Participation rates in 2015, 2017 and 2019, for local governments with an elector base in excess of 40,000 are compared in the following table.

Participation Ratio for Metropolitan and Country Districts

Of the 494,058 postal votes received in 2021, there were 373,582 (75.6%) from the metropolitan area and 120,476 (24.4%) from country areas.


The Town of Cottesloe recorded the highest metropolitan participation rate in 2021 with 47.4% and the City of Wanneroo the lowest with 25.2%.


By comparison, in 2019 the Town of Cottesloe again recorded the highest metropolitan participation rate of 46.5% and the City of Gosnells was the lowest at 22.7%.

The Shire of Victoria Plains again recorded the highest participation rate for country local governments with 68.9%, compared to 73.7% in 2019. The Shire of East Pilbara was again the lowest in 2021 with 19.1%, compared to 21.9% in 2019.

The average participation rate for metropolitan local governments at the 2021 local government elections was 29.3%, compared to a 33.5% average for country districts.

The graphs below provide a complete breakdown of postal participation rates for metropolitan and country local governments.






Age of Electors and Voters

The Commission uses six age groups for comparison purposes to ascertain voting trends.


In the 2021 elections the lowest voter participation was in the 18–24 age group, the highest among electors 65+. A similar trend was evident in 2019. The low voter turnout for younger electors is still an issue.






Enrolment and Voter Participation Comparison

MAIL

Late Mail

Unfortunately, as is normally the case, some electors did not return their completed package in time for them to be included in the count. Late mail details for each local government are shown at Appendix 14.

The Commission endeavoured to minimise late mail by arranging a special delivery through Australia Post on the morning of election day, as well as including relevant messages in the election package and in advertising and media releases.

Voters also had the option of returning their completed package by hand to their local government's polling place(s) by 6.00 pm on election day.

Unclaimed Mail

Of the 1,635,288 packages dispatched, 2.0% were returned unclaimed, compared with 1.8% in 2019.

Details were forwarded to the Australian Electoral Commission to assist with enrolment review. Appendix 15 shows the number of unclaimed mail as a percentage of the total packages dispatched for each local government.

COSTS

At the October 2021 postal elections, the average cost per elector increased by 9.8% to \$4.06 in comparison to the 2019 postal elections. The increase was largely caused by increased postage costs for the election packages (both outgoing and incoming), which increased by 11% (outgoing) and 9% (incoming) from 2019.

The Commission is required to conduct local government elections on a full accrual cost recovery basis. Whilst cost estimates are provided prior to the election, the actual cost incurred must be passed on. The estimates include approximations of the number of candidates, electors, mailing delivery service used, staffing requirements and the number of returned votes by electors.

FUTURE DIRECTIONS

While the 2021 local government elections were generally very well managed and filled 463 of the 471 vacancies up for election, there remain some matters that are of concern to the Commission.

- The cost of postal elections continues to rise with the Australia Post cost component of the entire local government postal elections conducted by the Commission, rising from just over 29% in 2019 to well over 32% in 2021.
- Cost increases and reported declines in the service level provided by Australia Post, particularly in some regional areas of the State. There was a 50% rise in the number of in person elections.
- The Commission recognised a gradual improvement in some metropolitan postal delivery areas to pre-COVID-19 delivery times. However the general time delay experienced with the delivery of residential addressed mail continues to be of concern. Such delays not only reduce the time available for electors to complete and return their election packages, it can also make it more difficult for candidates to plan their campaigning activities.
- From the Commission's perspective, while late mail represents a low percentage relative to the total volume of packages distributed, the figure continues to be disappointing and reflects the Commission's view that the current period available for package production, distribution and return following the close of nominations is too short given the volumes that are now required to be produced and posted.
- This period of time imposed by the legislation means that many postal voting packages arrive in letterboxes in the first week of the Term 3 school holidays. This creates problems for campaigning and reduced response times for electors to return completed packages when they are away on holidays.

The Commission has previously raised these concerns with the Department of Local Government, Sport and Cultural Industries and it is understood that the Government intends to examine this issue in future legislative amendments.

As a potential solution, some local governments continue to ask the Commission about the possibility of using technology assisted voting solutions such as internet based voting systems to reduce costs and improve elector participation and the voting experience. The Commission remains committed to investigating such solutions for the future and looks to Government for support in their development.
