

Disclosure of political contributions

Electoral Act 1907, sections 175M and 175MA

This form is to notify the Western Australian Electoral Commission that a donor has made a political contribution, or to provide information about a series of contributions from the donor.

Political contributions more than the specified amount of \$2,600 are to be disclosed.

Political contributions received from the same donor in the same financial year, that have a combined value of more than the specified amount of \$2,600 are to be disclosed.

Once political contributions from a donor have exceeded \$2,600, any subsequent political contributions from the donor in the same financial year are to be disclosed.

Timeframe for notification

The disclosure of a political contribution, or a series of political contributions, should be within the following timeframes once the specified amount is exceeded:

- 1. Non-election period: within seven days of being received.
- 2. Election period / capped expenditure period: by the end of the next business day after being received.
