Candidate statement and declaration

- I am not subject to any legal incapacity.
- I am an Australian citizen.
- I am an elector entitled to vote at an election in a Western Australian State district.
- I am qualified² under the laws of the State to be elected as a Member of the Legislative Council.
- I am not, and do not intend to be, a candidate in any other election to be held on the same day as the election to which this nomination relates.
- I consent to act as a member of the Legislative Council if elected.
- If successful, I consent to my details being provided to Parliament for contact purposes.
- I wish my name to appear on the ballot paper in the form shown opposite.
- I apply to have the following registered political party name printed adjacent to my name on the ballot paper.

Notes:

- The candidate's name to be printed on the ballot papers shall include the candidate's surname and may include each, or one or more of the candidate's given names.
 For this purpose, a given name may be:
 - (a) the name
 - (b) an initial standing for the name, or
 - (c) a commonly accepted variation of the name (including an abbreviation or truncation of the name or an alternative form of the name).
- 2. For qualifications of candidates, refer to *Eligibility for Membership of State Parliament* brochure and *Candidates Guide Legislative Council*, published by the Western Australian Electoral Commission or the *Electoral Act 1907*, the *Constitutions Act Amendment Act 1899* and other relevant legislation.

An additional form which may require completion is Form RO21 *Withdrawal of claim for grouping of candidates*.

This completed form must be returned to your party secretary as soon as possible to allow time for lodgement of the application and the required deposit with the Electoral Commissioner for Western Australia.
