





Mr Ben Morton, the party agent for the Liberal Party of Australia (Western Australian Division), gave notice under section 175X of the *Electoral Act 1907* that the return lodged on 29 October 2013 with the Western Australian Electoral Commission (the Commission) was impossible to complete as he was unable to obtain particulars that were required for the preparation of the return.

Mr Morton identified that he believed on reasonable grounds that individuals he named in the notice would be able to provide the Commission with the necessary particulars to complete the Liberal Party of Australia's (Western Australian Division) annual return for 2012-2013.

The Commission will contact the individuals named to seek the supply of those particulars identified by Mr Morton.
