6	The decision to "completely outsource" recruitment of TEWs to an independent recruitment agency should be reconsidered by WAEC, having regard to: (1) the cost compared to cost of "in house" recruitment, using ROs to recruit; (2) the specialised nature of the temporary work, related solely to elections; and (3) public perception, and consider whether WAEC should employ all TEWs directly for General Elections and should only engage recruitment agencies to recruit TEWs for Early Polling until it is sufficiently funded to recruit TEWs for Early Polling itself.
